- 1. Fill out the membership information form online, then return it to the above address. If paying by credit card, please email the form to <u>administration@teaneckswimclub.org</u>. A payment to "Teaneck Swim Club" should accompany your membership form. If you are using a bank payment system or credit card, **this form must be filled out and returned separately**.
- 2. If there is an error in your invoice or a change in your membership status, please email <u>membership</u>. Returning members must pay dues and admission fee payment unless they have resigned in writing by March 25. <u>Click here to</u> see rules for dues and seasonal admission fee payment and resignation.
- 3. All members are assessed a bond (Teaneck residents) or bond equivalent (non-Teaneck residents). The total cost of the bond is \$500. It may be paid in full or in installments of \$125 over four years. Until the bond is fully paid, members will be considered "pre-bonded" and will not have voting rights, may not serve on the Board of Trustees or receive a refund after resignation. **Only a fully paid bond will be eligible for refund**.
- 4. Each member unit pays \$200 membership dues plus a season admission fee based on the size of the family as listed below. Renewing members must pay dues every year to maintain membership in good standing, but do not have to pay the season admission fee if not planning to use the facility in any given year. A \$50 discount can be taken if all fees are paid in full and received by March 25th. A \$25 discount can be taken if all fees are paid in full and received by May 15th.
- 5. Family members included in a family membership must live in the same residence and proof may be required. Grandchildren and caregivers may be added for an additional fee and do not have to live with the family. Caregivers will be admitted only with their charges and may not bring guests. Additional adults must live with the family. Limit of one caregiver per family.
- 6. Badges must always be presented to gain access to the swim club. There is a \$5 charge for replacement badges.
- 7. The New Jersey sales tax on dues is already included in the dues portion of the payment.
